<b>Greeley Action Lab</b>	<b>Kim Fairley</b> , North Colorado Health Alliance, presented information about the Greeley Action Lab: <ul style="list-style-type: none"> <li>• 100-day project aimed at reducing inappropriate usage of 911 and avoiding unnecessary transport to the ER</li> <li>• Numerous community partners participated, including multiple health care agencies, Greeley Fire and Police, Greeley Public Library</li> <li>• Emergency responders (Fire &amp; Police) were integral to the success of the program</li> <li>• Partnerships were created across multiple social agencies</li> <li>• Next phase will look at the sustainability of the project and build on successes and learnings of the 100-day project</li> </ul>
<b>Medicaid Update</b>	<b>Marty Janssen</b> , Colorado Access, gave brief update on pertinent Medicaid policies: <ul style="list-style-type: none"> <li>• March 1 launch of new MMIS and Provider Portal</li> <li>• Providers should review deadlines for submitting claims for payment in February</li> <li>• There will be a lag in payment as the new system launches</li> <li>• New “look and feel” to Redetermination and IEVS letters.
